Education & Information – Bettering Themselves

Inmates face heightened obstacles upon release when they lack education and relevant skills, and GTL's education applications seek to diminish these obstacles. Educational content is provided to inmates through a Learning Management System (LMS) that is similar to platforms used in K-12 education. The LMS comes pre-loaded with 25 self-help courses ranging in subject from anger management to job interview preparation. Inmates can enroll in the courses and/or be assigned courses as part of their sentencing.

Other educational opportunities are available through GED® prep modules, with comprehensive instruction in the areas of language arts, math, social studies, science, and consumer education assisting inmates in studying for a high school equivalency exam. The KA Lite application (the offline version of Khan Academy®) offers 20,000 practice exercises; 7,000 instructional videos; and a personalized learning dashboard that empowers learners to study at their own pace on subjects such as English, history, computer programming, and economics.

In addition to educational content, inmates need to be informed about the correctional facility in which they are housed. The Documents application organizes all facility documents in one location so inmates can quickly view a variety of digital files, including the rules and regulations handbook, commissary menu, and more. The application gives inmates access to pertinent information at any time and enables facilities to upload documents electronically, saving costs on printing and distribution.
